Reviewing the Family Court "Parenting Through Separation" Participant Feedback

September 2011

Overview

Parenting through Separation is a free voluntary information programme for parents and aims to help separating parents help their children. The Ministry of Justice funds providers across the country to deliver the programme. It usually takes place over two sessions of about two hours each and is delivered to groups of up to 16 parents. The content of the programme covers:

- how separation affects children
- what children need during separation
- talking with children
- talking with ex-partners about arrangements for the children
- keeping children away from arguments
- how the Family Court works.

For each participant, a registration form is completed, and at the end of the sessions they are invited to complete an evaluation form. The evaluation form consists of closed questions with scales and one final open ended question. Most parents complete this form.

This paper presents data extracted from the closed questions on the registration and evaluation forms. The data presented in this paper is only for those participants who completed the evaluation form and covers the period from May 2006 (when the programme commenced) until the end of 2010.

The data are presented in the following sections:

- top-line results
- sample description
- selected cross-tabulations
- all variables cross-tabulated by ethnicity.



Top-line results

Participants were asked whether they agreed or disagreed with eight statements about the programme.




Figure 1: Level of agreement with statements about the programme


